### **INSURANCE COST & POINT REDUCTION COURSE**

CSEA Local 865 is sponsoring a six (6) hour Insurance Cost and Point Reduction Course from 9AM to 3:00 PM (including a half hour lunch) on **Saturday, March 20, 2010.** All CSEA Local 865 members and their families are invited to participate in this one-day program.

This program will reduce your auto liability insurance by 10% per year for three years, and remove up to four (4) points from your driving record. By taking the course, drivers with excessive points can avoid possible revocation or suspension of their license; however, it will not override a mandatory suspension or revocation (e.g. 3 speeding tickets in 18 months). All drivers are eligible regardless of violation or accident record, including assigned risks, persons under 25, senior citizens and commercial vehicle and motorcycle operators. The main focus of this course is to allow drivers to discover their driving attitude and the effect it has on the way they handle themselves on the road.
